# DE PASRR Program - Important Provider Update: Go-Live Date for the AssessmentPro Interface With Delaware Medicaid Enterprise System (DMES) Scheduled for Monday November 18

Please be aware that beginning **Monday, November 18**, the AssessmentPro System will be updated to include connection to the Delaware Medicaid Enterprise System (**DMES**).

## DE PASRR Program - Quarterly Provider Newsletter: PathTracker and ServiceMatters Best Practices

1. Effective August 1, 2024, Nursing Facility users completing an admission record in PathTracker will be required to attest that your facility is prepared to provide the services listed in the PASRR (if applicable) before you can proceed with the admission form.

This requires that you have **obtained a copy of the PASRR Level I or II notice and reviewed it** prior to completing the admission.

2. It is essential that Providers closely monitor the PathTracker Admittance Queue and ensure the queue remains up-to-date. Keep in mind that PathTracker will be directly linked to your payment, so be sure to regularly update PathTracker to reflect who is in your facility every time a client admits to or discharges from your facility.

Likewise, we ask that Providers ensure the Census Queue reflects who is currently in the facility.

3. If you are a **ServiceMatters Respondent** (this can be identified under user roles on your AssessmentPro profile), please review the ServiceMatters Review tab frequently, and update as needed. Please be aware that as of August 1, 2024, Providers will be required to acknowledge an attestation when submitting a new referral. Before each submission, you will be prompted to read and acknowledge. The attestation box must be checked to allow the submission to continue (see below).






#### Admitting an individual:
