Activities of Daily Living (ADL)	Basic activities of self-care performed by individuals on a daily or frequent basis necessary for independent living and may include activities such as: bed mobility, transfer, locomotion, eating, toilet use, bathing, and dressing.	
Assessing Services Agency (ASA)	The entity that contracts with the Department to conduct standardized assessments that determine eligibility and communicate service options to individuals seeking State-funded and MaineCare program Long Term Care (LTC) services.	
Caregiver Questionnaire	A phone interview conducted with the Resource Parent/Family.	
Child and Adolescent Functional Assessment Scale (CAFAS) and Preschool and Early Childhood Functional Assessment Scale (PECFAS)	Tools used for assessing a child's day-to-day functioning and for tracking changes in functioning over time. The CAFAS and PECFAS are widely used to inform decisions about type and intensity of treatment, level of care, placement, and need for referral. Foster Care	A temporary living arrangement in which a Resource Parent/family provides care for children who are in the custody of the Department.	
Geropsychiatric Unit (GPU)	A specialized medical facility capable of providing acute inpatient psychiatric services to medically complex or unstable patients.	
Health Insurance Portability and Accountability Act of 1996 (HIPAA)	As defined in Public Law 104–191.	
Instrumental Activities of Daily Living (IADL)	Activities necessary for maintaining a person's immediate environment, such as preparing and serving meals, washing dishes, dusting, making beds, picking up living spaces, sweeping, vacuuming and washing floors, cleaning appliances, changing linens, removing refuse, shopping for groceries and prepared foods, storing of purchased groceries, and laundry, either within the residence or at an outside facility.	
Intake	Services that involve acceptance of referrals for OADS and OCFS assessments.	
	a. OADS referrals shall be received from the Department and the public, including consumers and their families, hospitals, nursing and residential care facilities, home care providers, and physicians via telephone, fax, or Department-approved secure web portal and responding to requests for information regarding PASRR and LTC services and supports.	
	b. OCFS LOC Child referrals shall be received from the Department via email.

Maine Automated Child Welfare Information System (MACWIS)	The computer system for recording Maine's child welfare information.
Medical Eligibility Determination (MED) Form	The form used for Medical Eligibility Determinations and service authorization for an authorized Plan of Care based upon the assessment outcome scores developed by the ASA and given to the provider.
Plan of Care	A document authorized by the Department that specifies all services to be delivered to an individual based upon the individual's assessment outcome scores, applicable timeframes, and professional clinical judgment of the assessor. The Plan of Care reflects the needs identified by the assessment, taking into account the individual's living arrangement, informal caregiving supports provided by family and friends, and services provided by other public and private funding sources.
Quality Assurance	A system for evaluating performance, for the delivery of services or the quality of products provided to consumers, customers, or patients.
Quality Improvement	Consists of systematic and continuous actions that lead to measurable improvement of services to consumers, customers, or patients.
Quality Review	A service review to determine the quality of service provided. Quality Reviews include but is not limited to information, data, and procedures to determine the extent to which the information, data and procedures are accurate and reliable.
Resource Parent/Families	As defined in 22 M.R.S.A. § 4002(9-D).
Service Coordination Agency	An organization that has the statewide capacity to provide care coordination and skills training to individuals receiving services and has met MaineCare provider enrollment requirements.
Special Review	A non-scheduled review that may be conducted in response to a claim that a child's needs have substantially changed or that pertinent information was not available at the time of the previous review. These reviews may be requested by the caseworker, Resource Parent/Family, or the child placing agency staff.
