**Q:** Should a Status Change be submitted for a medication being added for someone with a primary Dementia diagnosis that has already been ruled out of PASRR population?

**A:** No, a Status Change is not required for an individual being prescribed an added medication if Maximus has ruled them out for a Dementia Exemption.
