As COVID-19 related guidelines continue to evolve, LTC medical assessments currently being performed by virtual or telephonic means will begin moving toward an in-person assessing model. With this transition in mind, the Maine ASA team is currently seeking Registered Nurses (RNs) to perform LTC medical assessments in locations across the state, including Androscoggin, Cumberland, Knox, Lincoln, and York counties.

### WE ARE SEEKING LICENSED REGISTERED NURSES TO ADMINISTER LONG TERM CARE (LTC) ASSESSMENTS

#### MINIMUM REQUIREMENTS:

Must be a Registered Nurse (RN) under the Maine Board of Nursing with a minimum of one (1) year nursing experience, as dictated by client contract. At least four (4) years of clinical experience. Preferred home healthcare and/or long term work experience. Knowledge of state contract and methodology preferred. Experience level is dictated by client contract.

Perform all job duties in compliance with Person First standards, HIPAA guidelines, and company confidentiality policies and procedures.

Excellent knowledge of diverse cultures and issues, with the ability to incorporate special needs into utilization review decisions.

Excellent written and verbal communication skills.

Ability to work independently, as well as within a team while exhibiting excellent interpersonal skills.

Work on-call rotation to support hospital assessments during weekends and holidays as required by client contract.

Job requires extensive travel using personal motor vehicle. Due to the nature of the job, a valid driver's license and reliable transportation is required. The incumbent is responsible for submitting updated.

Working knowledge and understanding of medical diagnoses and prescribed medications.

Ability to multitask while effectively performing job duties, which include prioritizing tasks; ensure all voice mail and email messages are monitored and responded to within 24 hours of receipt or as required by client contract.

Strong computer skills with experience in word processing, email and spreadsheets (MS Word, Outlook, Excel preferred); ability to work securely in remote locations, research information on the internet, utilize company resources/ tools stored on company sites.

Ability to interact professionally and collegially with State Stakeholders (hospitals, nursing facilities, physicians, community service workers, etc.), state contract officers, and coworkers while seeking or providing information.

Ability to collect data, define problems, establish facts, and draw valid conclusions for supporting a superior written rationale for review determinations.

#### ESSENTIAL DUTIES & RESPONSIBILITIES:

- Responsible for completing timely and quality assessments per working day.
- Conducts on-site and telephonic long-term care assessments to determine an individual's needs for long-term services and supports.
- Ability to work flexible schedule including evenings, weekends and holidays as required by client contract.
